Each year the program would send cadres of approximately 100 students from historically disadvantaged South African communities (i.e., Africans, 'Coloreds,' and Indians) to study at US universities. Denison University's orientation program was created to help sharpen the student's study skills and help them adapt to the US system prior to beginning their degree programs at their respective universities. Along with Denison University co-Directors, Professor Donald Schilling and Professor Richard Lucier, we developed the students' academic and cultural adjustment programs, working with several other Denison University professors on the academic staff and a number of Residential Life staff.
